## PREFACE

I started to research the Wallace family from the Eastern Coast of Scotland when I began my genealogical inquiries into my father's family. He was George Alexander Bain (1913-2006) and, like me, he was born in Canada, to which his parents, Thomas Bain (1888-1969) and Margaret Smart (1880-1915), had emigrated in 1911 and 1912 respectively.

The Bain inquiries led me to conduct further research on my Scottish ancestors, eventually leading me to the Wallaces. George Wallace (b. and d. unknown; 1) was my paternal third great grandfather. He married Margaret Clark (b. and d. unknown; 1a), and their great granddaughter Margaret Smart (1.3.6.3) married my grandfather Thomas Bain (see above), thereby linking the Wallaces to the Bains. The history of the Bain family is given separately.

Each member of the Wallace family has been recorded using the d'Aboville System, a descending sequential numbering method developed by Count Jacques d'Aboville in 1940. Descendants are assigned the number of their parent, followed by a number indicating their order of birth. Spouses of direct descendants are denoted by the number of their partner, followed by a, b (if an individual marries twice), and so on. Stepchildren follow the line of their birth parent. The number of digits indicates the relevant generation. This system ensures that each individual has his or her own unique number. For example:

- 1.3.6.3 Margaret (Meg) Smart – the third child of:
- 1.3.6 Elizabeth Wallace – the sixth child of:
- 1.3 Robert Wallace – the third child of:
- 1 George Wallace.

In referring to "great" antecedents or descendants, the number of "greats", counting the first, is denoted by an ordinal number. For example: my great great great grandfather George Wallace (see 1 above) is my third great grandfather.

Where a given name is italicised, this indicates the preferred name by which the individual was known; it may be a second or third name, pet name or abbreviation, rather than that with which they were baptised.

Most of the notes to the tables in Section 5 of this volume refer to information that was available up to circa 2004, except for a small number that have been updated to 2013. Biographical notes have generally not been attached to the entries for children born after the mid-1980s.

In compiling this family history, I have benefitted from the help of several individuals. My greatest debt is to my second cousin, Morag Smith (née Smart; 1941-2013), of Laurencekirk in Aberdeenshire (formerly Kincardineshire), for her indefatigable support. Morag not only carried out her own research but also played a hugely significant role in contacting other relatives to gather further information. Sadly, she died before this family history was published and hence did not see the results of the project in which she played such an important part.

I am also very grateful to two genealogists – the late Daniella Shippey of Ancestry Research in Edinburgh, and Jean M. Brodie of the Scots Ancestry Research Society – whose professional input underpins the production of this history.

My thanks are also due to Dr Tyrone Bowes of Irish Origenes, whose DNA research confirmed my ancestral links with eastern Scotland. His findings are reported in Section 6 of this volume.

As the work progressed, I delegated the typing and, later, the word processing, to professional secretaries. Two require special mention and thanks: Linda Lowther, who was a colleague at the London Business School during the 1990s, and particularly Pauline Allen, who worked closely with me from 1998, when I joined Queen's University Belfast, and has continued to do so after my retirement from Queen's in 2004 until the present day. The meticulous work of marshalling all the information into tabular form is primarily her handiwork.

Once the research was completed and the resulting information was put in tabular form, it had to be prepared for publication. I am grateful to digital designer Jim Armstrong for drawing the map, and to Jonathan Ridgway and his colleagues at print management specialists CDS for producing the finished version. Before they could do so, however, the entire typescript had to be copy edited. Anne Langford, a former colleague at Queen's, undertook this exacting task by, among other things, assigning a d'Aberville number to each individual, standardising the layout and references, checking and proof reading, drafting the Preface and Introduction, removing infelicities, and managing print and design. I am most grateful for her professional support and – since births, marriages, and deaths are never-ending – for encouraging me to draw the project to a close and to publish it.

I am also grateful to the following institutions, in whose libraries copies of this volume have been deposited: the Public Record Office of Northern Ireland in Belfast, the Ulster Historical Foundation in Belfast, the Linen Hall Library in Belfast, the Mellon Centre for Migration Studies in Omagh, the Scottish Genealogy Society in Edinburgh, and the Court of the Lord Lyon in Edinburgh.

Despite everyone's efforts, I am sure that errors remain in the multitude of data and facts that have been assembled. For these, I am responsible.

## INTRODUCTION

Although one of the most famous Scottish surnames, the name Wallace may have been of English, Welsh or Breton origin. “Recorded in the spellings of Wallace, Wallice, Walles, Wallis and Wallas, and first recorded in England, the surname derivation is from the Norman French word ‘waleis’, meaning a ‘foreigner’. In England this was generally taken to mean a Welshman or a person living in the border counties of England and Wales, or a Celt from Cornwall, or a former Breton who settled in East Anglia after the Norman Conquest . . . The surname is first recorded in Scotland in 1190 when one Richard Waleis witnessed a charter relating to Kelso Abbey . . . The first recorded spelling of the family name is shown to be that of Osbert Waleis, which was dated circa 1156, in the “Book of Seals” of Warwickshire.”<sup>1</sup>

The first of the Wallaces whom I can definitely claim as a direct ancestor is **George** (1), a “lint miller”, and my third paternal great grandfather. His dates of birth and death are unknown, as is his place of birth, but it is known that he and his wife, **Margaret Clark** (b. and d. unknown; 1a), had three children. The third of these, **Robert** (1809-92; 1.3), was my second paternal great grandfather. There is no trace of descendants for Robert’s brothers, **William** (1804-?; 1.1) and **David** (1806-?; 1.2).

### Robert Wallace (1.3) and Descendants

Robert, a “tailor”, married **Mary Millar** (1815-84; 1.3a) in 1835 and they had six children, two of whom – **Margaret** (1841-?; 1.3.3) and **Alexander** (1849-61; 1.3.5) – died young. There is no trace of a marriage for their second child, **Robert** (1839-?; 1.3.2). Their eldest child, **Mary Ann** (1835-?; 1.3.1), married and had one child, but her descendants could not be traced further. Their fourth child, **David** (1844-1901; 1.3.4), married and had children, whose descendants are traced in this family history.

Robert’s youngest child, **Elizabeth** (1852-1936; 1.3.6), was my paternal great grandmother. Elizabeth married my great grandfather **Alexander Smart** (1852-1922; 1.3.6a), a “gamekeeper” and “shipyard worker”, in 1876 and they had seven children, of whom the third, **Margaret (Meg)** (1880-1915; 1.3.6.3), was my paternal grandmother. Margaret emigrated to Canada in 1912 and married my grandfather, **Thomas (Tom) Bain** (1888-1969), who had emigrated from Scotland the previous year, in Winnipeg. Their descendants are listed in the history of the Bains, which is given separately.

Elizabeth’s eldest child, **Robert** (1877-1915; 1.3.6.1), also emigrated – to Brisbane in Australia, where he travelled in 1910 to manage Eager’s Motors. Of her other children, three – **Mary** (1879-1973; 1.3.6.2), **Jane** (1882-1969; 1.3.6.4), and **Thomas** (1885-1949; 1.3.6.6.) – married and had children. Their descendants are listed in the history of the Smarts. There is no trace of a marriage for **Alexander** (1883-?; 1.3.6.5). Elizabeth’s youngest child, **Alice** (1889-1982; 1.3.6.7), a spinster, worked as a nanny in Australia and as a lady’s companion in the United States before retiring to Scotland.

### Location

Robert Wallace (1.3) was born in Fettercairn, a small village in Kincardineshire, a former county on the coast of northeast Scotland, which is now part of the Aberdeenshire council area. He later moved to Logie Pert in the neighbouring county of Angus (formerly Forfarshire), and subsequent generations

settled primarily in the county town of Arbroath, and further south in Kirkcaldy, Leslie and the new town of Glenrothes in Fife.

Except for Robert (1.3.6.1) and Margaret (1.3.6.3), who emigrated to Australia and Canada respectively, and their sister Mary's daughter, Margaret (Meg) Hampton (see history of the Smarts), who emigrated to New Zealand, the Wallaces and their descendants remained in Scotland, and many were still living there at the turn of the 21st Century.

The descendants of David (1.3.4) and of the three children of Elizabeth Smart (1.3.6) – Mary (1.3.6.2), Jane (1.3.6.4), and Thomas (1.3.6.6) – all of whom married, had children and remained in Scotland, are traced in the history of the Smarts.


As a result of Robert's emigration to Australia, Margaret's emigration to Canada, and their niece Margaret's emigration to New Zealand, many Wallace descendants are now to be found in these countries and, in the case of the Bains, also in the United States. Their stories are told in the histories of the Smarts and Bains, which are published separately

### **Socio-economic Status**


The Wallaces were an upper working-class family. A significant number were skilled tradesmen, while others found employment in the retail sector and in clerical positions, and many females worked in domestic service. There was a significant family tradition of tailoring in the earlier generations: Robert (1.3) was described in the 1881 Census of Population as a "tailor, master employing 1 man and two boys"; his son David (1.3.4) was described in the 1891 Census of Population as a "tailor" living with his wife, children, two apprentice tailors and two servants; and his grandson David (1.3.4.6) was described as a "tailor's cutter" at his marriage, and as a "tailor, retired" on his death certificate. David's wife, Hel(l)en (née Robertson) (1.3.4.6a) was described as a "tailoress" on her marriage certificate. Morag Smith (née Smart) wrote "there certainly was a tailor in Edzell called David Wallace who owned a business going under the name of Wallace & Robertson, Robertson having been his wife's maiden name. They had one daughter called Kathleen who was a domestic science teacher." Kathleen (1.3.4.6.1) is, however, described as a "librarian (retired)" on her death certificate.

Later generations, particularly the descendants of Robert and Margaret (Meg) Smart (see above), were upwardly mobile, with many individuals in Canada, the United States and Australia pursuing successful professional careers.

1. No trace of his birth or baptism in the Old Parish Registers of Kincardineshire, 1760-87.

He is described as a “lint miller” on his son Robert’s death certificate.

No trace of him or his wife in Fettercairn in the Census of Population for 1841 and 1851, or in Logie Pert in the Census of Population for 1841. No trace in Scotland of his death, 1855-92; he probably died prior to the start of statutory registration in 1855. A search of the Old Parish Registers of Fettercairn, 1809-54, produced two possible entries for his death:

“1810 April 22  
To 1<sup>st</sup> Mortcloth to Geo. Wallace 5/-”

“1836 June 27 To Mortcloth Geo. Wallace 3/6”

But it is not possible to prove that either entry is relevant.

- 1a. A search for her birth in the Old Parish Registers of Fettercairn, 1765-87, produced three possible entries:
- “1769 Octr. 15<sup>th</sup> John Clark & Margt. Gibb in Cleerie had a Daugr. Bap. called Margaret”
- “1770 (Aug.) Do. 20<sup>th</sup> Geo. Clark in Denstrath & Jean Mitchell had an adulterous bastard bap. Margt”
- “1775 Ap. 16<sup>th</sup> Robert Clark and Margt. Balfour in Denstrath had a dau. Bap. Margaret”
- But it is not possible to identify the relevant entry.
- Fettercairn has no record of marriages, 1744-1825.
- No trace in Fettercairn of any other children from her marriage, 1798-1804.
- A search of the Old Parish Registers of Fettercairn, 1809-54, produced two possible entries for her death:
- “1822 March 9 To Mortcloth --- Clarke 5/6”
- “1825 May 1 To Mortcloth Widow Clarke 3/6”
- But it was not possible to identify the relevant entry.
- No trace in Scotland of her death, 1855-92.
- No trace of his marriage in the Old Parish Registers of Fettercairn, 1821-54. The following entry in the Old Parish Registers of Fetteresso might be relevant:
- 1.1 “1845 June 15<sup>th</sup>  
William Wallace and Jean Mowat both in this parish”
- No trace of him in Fettercairn in the Census of Population for 1841 and 1851, or in the index to the 1881 Census of Population for Scotland. The following entry in the 1871 Census of Population for Laurencekirk might be relevant:
- “Address: Middleton (two rooms)  
Helen Finlay, head of house, widow, aged 47, born in Kincardineshire, Garvoch.  
William Wallace, boarder, married, aged 66, agricultural labourer, born in Kincardineshire, Fettercairn”
- There was no trace in Kincardineshire of children fathered by the above William Wallace.
- A search of the Old Parish Registers of Fettercairn, 1814-41, produced only one possible entry for his death:

“1815 Jany. 29  
To 1<sup>st</sup> mortcloth to Willm. Wallace 4/-”

But this entry could not be proved relevant.

1.2                   No trace in the Old Parish Registers of Fettercairn of his marriage, 1823-54, or his death, 1806-54. No trace of him in Fettercairn in the 1841 and 1851 Census of Population, or in the index to the 1881 Census of Population for Scotland. No trace in Scotland of his death, 1855-1911.

At the 1851 Census of Population, he was a “tailor, master with an apprentice – John Smith, unmarried, aged 15, born Stricathro [sic], Forfarshire – at Hill of Conony, Logie Pert. He is described as a “tailor” on his daughter Mary Ann’s marriage certificate in 1859. At the 1861 Census of Population, he was a “tailor employing 1 man” living with his wife and children in a two-room dwelling in the village of Arbirlot. At the 1871 Census of Population, he was still “a tailor employing 1 man”, living in Arbirlot with his wife Mary,

and children David and Elizabeth. At the 1881 Census of Population, he was a “tailor, master employing 1 man and 2 boys” living in a two-room dwelling in Arbirlot. At the 1891 Census of Population, he was a “retired tailor”, widower, living with his grandsons William and George.

He is described as a “tailor” on his death certificate. He died in the village of Arbirlot.

1.3.a At her marriage, she was living in the Parish of Logie Pert. Her name was spelt Miller on her birth and marriage certificates. Witnesses at her baptism were John Miller [*sic*] of Caldham and George Smith of Marykirk.

At the 1881 Census, no entry was found for her in any parish in North-East Scotland.

She died in the village of Arbirlot.

Daughter of John Millar, mason, and Margaret Millar (née Garvie).

### 1.3.1

1.3.2 He is listed in the 1851 Census of Population as a “scholar” living with his parents and siblings in Logie Pert. No trace of him in the 1861 Census of Population for Arbirlot (where his parents were living). No trace of him in the 1881 Census of Population for Scotland. No trace of his marriage in the Counties of Angus and Kincardineshire, 1855-81. No death records exist in the Old Parochial Registers of Logie Pert, 1730-1854; no trace of his death in the Old Parochial Registers of Arbirlot, 1851-54, or in those of Angus and Kincardine, 1855-81.

1.3.3 She is not listed in the 1851 Census of Population with her parents and siblings, so she probably died young. Logie Pert has no records of deaths for this period.

At the 1861 Census of Population, he was a “blacksmith” living with his wife and son in a two-room dwelling in Arbirlot.

He is listed in the 1851 Census of Population as a “scholar” living with his parents and siblings. He is listed in the Census of Population for 1861 and 1871 as an “unmarried tailor” living with his parents and siblings.

My second cousin Morag Smith (1941-2013; see history of the Smarts) wrote (29 April 2003): “there certainly was a tailor in Edzell called David Wallace who owned a business going under the name of Wallace & Robertson, Robertson having been his wife’s maiden name. They had one daughter called Kathleen who was a domestic science teacher. She married a farmer (possible name Thow) but died a few years ago. I wonder then if David Wallace was a grandson of Robert Wallace and a son of either David or Alex and who followed his father and/or grandfather’s trade.” See nn. 1.3.4.6, 1.3.4.6a and 1.3.4.6.1.

At his marriage, he was a “tailor (master)” living in Arbirlot.

At the 1881 Census of Population he was a “tailor, journeyman” living in a three-room dwelling in Arbirlot with his wife and children, and Thomas Reid, boarder, aged 14, “apprentice tailor”, born Arbirlot, Forfarshire. At the 1891 Census of Population he was a “tailor” living in a four-room dwelling in Arbirlot with his wife and children; John Wallace, unmarried, aged 16, apprentice tailor, born Carnyllie, Forfarshire; and Alexander C. Alexander, unmarried, aged 16, apprentice tailor, born Carnyllie, Forfarshire; and two servants. At the 1901 Census of Population, he was a “tailor, employer” living with his wife and children in a three-room dwelling in Arbirlot.

He was the informant of his father’s death in 1892.

He is described as a “tailor and clothier” on his death certificate; he died in Arbirlot.

At her marriage, which was performed according to the forms of the Church of Scotland, she was a spinster living at home, 17 St Mary Street, Arbroath.

She died at 78 Keptie Street, Arbroath.

Daughter of William Martin, a builder, who was dead by the time of her marriage, and Jane Martin (née Whannel).

At the 1881 Census of Population, he was living with his parents and siblings. At the 1891 Census of Population, he was an unmarried “apprentice clerk” living with his grandfather, Robert Wallace, and his brother George.

No trace in Scotland of his marriage, 1893-1920, or his death, 1891-1976. No trace of him in the 1901 Census of Population for Scotland.

At the 1891 Census of Population he was a “scholar” living with his grandfather Robert Wallace and his brother William.

He was the informant of his father’s death in 1901. No trace of him in the 1901 Census of Population under the name of George Wallace. No trace in Scotland under his full name (George Wallace is too common a name to trace) of his marriage, 1899-1930, or his death, 1891-1982.

## Introduction

A diverse array of commercial ancestral DNA tests can be used to explore one's ancestry. By far the most popular is the autosomal test that sheds light on all an individual's recent ancestral lines. This test analyses autosomal DNA – the genetic material contained in the 22 non-sex chromosomes (i.e., excluding the X and Y chromosomes) – that are inherited from both parents, and the results can provide valuable information on an individual's ancestral ethnicity and genealogical relationships. Because a person's autosomal DNA is a random mixture of their mother's and father's DNA, it is unique to each individual, with the exception of identical twins.

Making sense of relationships revealed through autosomal DNA testing can be challenging. DNA tests can be used to verify relationships with a high level of accuracy for parent/child relationships and all relationships up to the second cousin (or fourth generation) level, but additional contextual and genealogical information is often required to confirm the exact nature of the relationship. The more DNA that two people share, the more recently an individual's shared (paternal or maternal) ancestor once lived. In addition, many of an individual's autosomal matches will reveal surnames and place names associated with their family tree, and these can hold crucial clues as to where the various lines in their ancestral tree originated.

## Interpreting the Autosomal Results


**Figure 1:** Some 60% of George Bain's Family Finder genetic matches record some sort of ancestral information (surname or location). Compared to a selected number of countries, both Scotland and Ireland feature prominently.

An examination of George Bain's FTDNA Family Finder autosomal DNA test results<sup>1</sup> revealed 2,010 genetic relatives (as of December 2016), 1,183 of whom record details of their ancestral surnames or locations. What is striking is that the locations revealed by the test subject's autosomal genetic relatives are *not random*; given their relative population size, Scotland and Ireland (where his ancestral connections lie) feature prominently; see **Figure 1**.

## Irish Autosomal Matches

George Bain's most recent ancestry lies within Ireland, and this is reflected by his autosomal results, where Ireland is recorded by approximately 26% of his ancestral matches that register ancestral information. An examination of the Irish counties listed among George Bain's genetic relatives reveals that the counties of Ulster feature prominently; see **Figure 2**.


Much of his ancestry lies among the Protestant Planter community within Northern Ireland and the Family Finder matches reflect relationships that developed among his Ulster relatives. His autosomal results also show the relationships that developed among his ancestral lines in specific locations and they can hold clues as to the origin of other (non-Irish) ancestors.

## Scottish Families


George Bain has strong ancestral ties with eastern Scotland where his Smart, Bowie, Stalker, Wallace and Wilkie ancestors originate. An examination of the distribution of Scottish Smart, Bowie, Stalker, Wallace and Wilkie farming communities reveals that they are prevalent within eastern Scotland; see **Figure 3**.



**Figure 3:** Surnames arose in an agrarian society and farmers with each surname can still be found concentrated in the areas where the first ancestor to take the surname lived. An examination of the distribution of Bowie, Smart, Stalker, Wallace and Wilkie farmers reveals multiple unrelated groups associated with different geographical areas. These groups, however, occur in closest proximity to one another in eastern Scotland (**red broken circle**) where the test subject's earliest Bowie, Smart, Stalker, Wallace and Wilkie ancestors are recorded.

Wallace, perhaps the most famous of these surnames, is associated with multiple locations within Scotland, with the most notable clan recorded in Ayrshire where numerous Wallace castles were located.

Approximately 20% of Scottish surnames are associated with a single geographical location, which means that each Scottish county has a “fingerprint of associated surnames”. This is best illustrated by several of the spousal surnames. Miller, the maiden name of Robert Wallace’s wife, Mary (1.3a; see p. 4), is, however, associated with multiple geographical areas; see **Figure 4**.

Wallace and Miller are among the most common Scottish surnames and are associated with multiple geographical areas, making it extremely difficult to identify a common area of association and a probable geographical location of a Wallace ancestral line for George Bain.

## **Summary**

Autosomal DNA is a term used in genetic genealogy to describe DNA within the autosomal chromosomes (i.e., the non-sex chromosomes inherited from both parents), which can be analysed to determine ancestral ethnicity and genealogical relationships. The details revealed by one's autosomal DNA matches are not random; they reflect the relationships that developed and were subsequently recorded by one's genetic matches. Linking ancestral lines to locations highlighted in an individual's genetic matches remains the challenge of modern autosomal DNA analysis.

The fact that Wallace is one of the most common Scottish surnames makes it difficult to ascertain exactly where George Bain's Wallace ancestors originated. Nonetheless, the confirmation by autosomal DNA testing of his ancestral links with eastern Scotland supports the genealogical research that traces his Wallace ancestors to the historic county of Kincardineshire.
